SYNOPSIS:

On 04/05/07 shortly after 0900 hours Greg Krzys received a threatening telephone call from a male caller that identified himself as [REDACTED]

ORIGIN:

On 04/05/07 at 1100 hours I responded to 5201 Ruffin Road, suite B to investigate a threatening telephone call.

INVESTIGATION:

Upon arrival I contacted the victim Greg Krzys and took his statement. There was no evidence located. On 04/03/07 Krzys was the victim of an attempted homicide in Riverside County. In that case a bomb was placed under her personal vehicle.

Today Krzys received a threatening telephone call shortly after 0900 hours. At the time of this report it was undetermined if the crime in Riverside County or this one were related. The caller provided Krzys a telephone number of [REDACTED]. No area code was given. A backwards telephone check showed the telephone number listed with a 619 area code to a [REDACTED]. There was no address listed on the phone number or for a [REDACTED]. The San Diego County ARJIS system did not show any record for a [REDACTED].

Krzys is an environmental land development planner with the County of San Diego. Krzys is working with Blackwater Development Corporation on a controversial plan for development in eastern San Diego County.
