On March 12, 2015, the California Public Utilities Commission (Commission) received your request for documents under the California Public Records Act (PRA), Gov. Code § 6250 *et seq*. In particular, you stated:

Please provide me copies of any and all emails written or received by [Terrie Prosper] regarding Michael Picker and the gala dinner honoring Michael Peevey last month. This CPRA request includes any emails containing any reference to the Feb. 12 event planning, financing, fund-raising, media responses, Goldman School of Public Policy, canceled checks, receipts or otherwise, dating from today's date back to Dec. 1, 2014.

Attached, please find the documents that are responsive to your request and are not exempt from production under the PRA. The responsive emails are being produced in three PDF files, labeled January 2015 Emails, February 2015 Emails, and March 2015 Emails.

As you will see, in the "February 2015 Emails" file, I have redacted the text of several emails between Christine Hammond, who is President Picker's Legal Advisor, and President Picker. These emails contain information that is subject to the attorney-client privilege and is therefore exempt from production under the PRA. Evid. Code § 954; Gov. Code § 6254(k). More specifically, the redacted text contains Ms. Hammond's legal opinion and/or legal advice to President Picker.

### San Francisco Business Times - Exclusive: 'We've got to upgrade everything,' says new chief of battered CPUC

In an exclusive interview, Michael Picker, the new president of the California Public Utilities Commission reveals his top priority. He also says what he thinks of Michael Peevey, the former CPUC boss who is being investigated by federal and state authorities. The CPUC is under scrutiny for having cozy relationships with PG&E and other entities it regulates as well as alleged back channel communications and possible trading of favors.

Michael Picker, the new president of the scandal-plagued California Public Utilities Commission, is stepping into a tough job at a tough time, but in an exclusive interview late last week said he has a plan to re-energize, refocus and reform the embattled agency.

The CPUC, a hugely powerful agency, has been a target of criticism for years, but the drumbeat has grown to deafening proportions.

The forced release of thousands of emails last fall between regulators, officials at PG&E and other utilities revealed cozy ties between the regulator and the entities it regulated as well as possible trading of favors.

The agency currently regulates nearly 11,700 companies — everything from utility and energy firms, telecommunications companies, water utilities, transit operators to the Ubers of the world. Consumers in California pay a cumulative \$50 billion annually for services produced by companies it regulates. And critics say regulated companies have been working the system to help the CPUC augment that hefty revenue stream.

"We are not an organization, we're sort of a conglomerate of different organizations, all housed within the same structure, with very little relationship to each other," Picker said.

It's a messy situation, that's at odds with Picker's instincts as a longtime governmental official, policy wonk, political consultant, and former senior adviser to Gov. Jerry Brown on renewable energy issues.

A key part of Picker's vision of reform is to build a stronger ethical and leadership framework for crucial issues. Some of those guidelines could be voted on by the Commission as early as this week.

It starts with creating "a job description for commissioners and a code of conduct for commissioners," he told the Business Times in a wide-ranging Feb. 19 interview.

It also means addressing "a real vacuum of leadership on safety issues" he said. The state agency and PG&E have been heavily criticized for how they handled the deadly 2010 San Bruno explosion and for the lax oversight that played a role in the tragedy.

Picker also plans to discard unnecessary bureaucracy, set clear internal expectations and build in accountability and standard organizational procedures. At the same time, he aims to retain the commission's historic goals of making decisions fairly and openly, sharing all important information publicly.

Everything from how commissioners and staffers interact with themselves and others — including PG&E workers they may know from "book clubs" and other social settings — to the laws that govern the agency's activities are on the table, Picker said.

The main objectives, he said, are "how do I make it a better organization that works well for everyone? ... How (do) you build a culture that can be more effective and less painful, excruciating and torture-some for people to navigate?"

During a more than hour-long interview with several Business Times editors and reporters, Picker outlined plans for a year-long strategic planning process. It will focus on improving the agency's ability to monitor safety problems in regulated industries, become more technologically adept, and rethinking internal structures and responsibilities.

He plans to craft a three-year plan to implement needed changes.

"This is the way you get to the level of performance and behavior you expect out of the CPUC," Picker told the Business Times, referring to plans to identify and develop needed skill sets, augment internal resources and ethical guidelines, while possibly pruning responsibilities that don't fit a more tightly focused entity.

Unlike some of his predecessors, Picker says, he doesn't want to simply clean house and bring in a whole new team of leaders, in part because he's convinced that the people who work at the CPUC "are better than the organization they're working for." Instead, the self-described bureaucrat from Sacramento wants "to have a much more orderly process" of restructuring and recasting a dysfunctional entity.

But fixing the agency won't be easy.

His immediate predecessor, Michael Peevey, stepped down in December after a 12-year tenure marked by kudos for his work on renewable energy but deeply tarnished by a burgeoning scandal. In addition to close ties between CPUC officials and officials at regulated companies, the agency has come under scrutiny for back-channel communications, alleged judge-shopping and possible trading of favors with Pacific Gas & Electric, San Diego Gas & Electric and other regulated entities. Both Peevey and the agency are being investigated by state and federal authorities. Critics such as the city of San Bruno, devastated by a 2010 PG&E gas pipeline explosion and fire, and The Utility Reform Network, a San Francisco-based ratepayers' advocacy group, say the agency has become corrupt and overly sympathetic to the companies it regulates.

The organization has serious structural and cultural issues that need to be repaired, Picker indicated, implicitly putting some of the blame on Peevey. "I don't think that he was a manager," he said. "He felt he was there to get stuff done, not so much to tend the machinery."

But in terms of the scandal itself, Picker sees two distinct sides of his predecessor.

"Mike Peevey did some awfully great things," he said, primarily as a leader of an effort over the last 12 years to greatly expand California's use of renewable energy and reduce its emission of greenhouse gases that contribute to climate change. "I don't think you can ignore the fact that he drove that."

As for the allegations against Peevey, Picker said bluntly, "I don't know what to make of it."

"Some of what I see is really unseemly, but (not) from what I can see, a crime. I can see unethical or inappropriate behavior, but a lot of that's inferred," Picker said. "But I'm not an investigator. There are two agencies that are investigating the CPUC. They'll answer that question for me and for you better than I can."

#### Fixing the mess

The CPUC needs a reboot, Picker made clear, both to rebuild public confidence and to do a better job at efficiently, transparently and effectively regulating several key industries in the state — assuming that some of those duties aren't yanked away from it.

"Nobody can really navigate the process. It's too arcane, too constrained by nature," Picker said. "Here's an example: I myself have never been able to find anything on our website."

Part of the broader problem he said, is that authority has been delegated from commissioners to staffers informally, without a paper trail or proper procedures, adding to confusing organizational chart.

"It's been word of mouth, kind of an oral history," Picker said. "You would think for an agency that's so big on the written process this stuff would be documented. But it's not."

To fix the organization's multiple flaws, Picker hopes to transform the tradition-bound agency into one that's far more nimble, technologically savvy, and accountable to the public.

He's already taken several steps in those directions, he said, including appointing former CPUC chief administrative law judge Timothy Sullivan as interim executive director of the agency. The CPUC also tapped a new director of its Safety and Enforcement Division, Elizaveta Malashenko, who previously served as one of its deputy directors.

He's told the agency's four other commissioners of his plans to focus on safety improvements, internal accountability reforms and studying other changes.

"The commissioners were a little stunned," Picker said. "They tend not to talk extemporaneously at commission meetings. It's all very scripted, because the commission record has regulatory impact, so they're very guarded. And nobody has ever talked about the commissioners setting organizational policy," as opposed to voting on utility rates and related issues.

"This is how you begin to change an organization," he said. "Showing a commitment to building (leadership) at the top, setting a direction, having a discussion with the staff, and having some strategic planning, which we're kicking off."

Whether Picker will have the freedom to pursue his year-long strategic planning process is unclear.

Several proposed bills in the California Legislature, by State Senators Jerry Hill (D-San Mateo) and Mark Leno (D-San Francisco) aim to reduce the CPUC president's power, tighten rules regarding back-channel communications between regulators and those they regulate, and make the commission more accountable to the public.

Picker would prefer to have the chance to do it his way, and suggested that the governor — who's been remarkably quiet publicly about the CPUC's recent scandals — supports his approach. "But if the commissioners have to respond to a proposed legislative action, we should give some guidance," he said.

If some of its responsibilities are shifted to other state agencies, "the moral challenge for us " is to make sure they're both willing and prepared to take them on, he said, and "have an understanding of the record that we've created in the past to set up these structures."

Picker sounds willing to part with some of the CPUC's unwieldy roster of responsibilities, possibly including oversight of car-sharing companies such as Uber and Lyft, which don't easily mesh with some of its other duties.

With regards to those so-called transportation network companies, or TNCs, "we just don't have the capacity" to monitor airports or other venues statewide to see if they're following the rules, he said. The agency has a good policy structure in place for economic analysis, but not to "actually take that policy out into the streets."

Some of the vast roster of organizations it regulates might be better monitored elsewhere in state government, Picker acknowledged.

"It's not right and appropriate to just kick them out the door," he said, referring to unnamed portions of the agency's oversight agenda, "although it may note be right and appropriate to keep them at the CPUC. All those questions are kind of things I worry about at <u>2 a.m.</u>"

Hi Jeff,

Sorry for the delay in responding. I know I missed your deadline, but I wanted to give you this info nonetheless. The CPUC, when faced with responding to a series of complex criminal and civil investigations by both the U.S. Department of Justice and the State Attorney General's Office, retained the services of an outside law firm with experience in counseling clients faced with responding to state and federal criminal investigations and complex criminal, civil, and regulatory proceedings. The State Contract Manual authorizes the hiring of outside counsel, and California Government Code sections 995.8 and 11041 allow a public entity to provide for the defense of criminal actions. The CPUC simply does not have the expertise, breadth of experience, resources, or time to handle internally the massive amount of work that needs to be done to effectively manage and cooperate with the investigations, while at the same time fulfilling its duty to act in the best interests of the public. The outside counsel does not represent former President Peevey or former Executive Director Clanon.
