**PLEASE TAKE NOTICE** that Petitioners and Plaintiffs’ will move this Court to hear its Motion to Enforce Settlement Agreement pursuant to California Code of Civil Procedure section 664.6, with a hearing set for November 1, 2019, at 1:30 p.m. in Department C-72 of the San Diego Superior Court, 330 West Broadway, San Diego, California 92101 before the Honorable Timothy B.
