Results of the 1% Manual Tally for the 6/3/2008 Direct Primary

Election

In compliance with Election Code Section 15360, the 1% Manual Tally for the Direct Primary Election was completed on June 19, 2008. Seventeen precincts were selected at random by an employee from the Planning and Land Use Group. Three additional precincts to cover remaining contests were selected by a member of the public. Tabulation system results include ballots cast by mail ballot and at the polls on optical scan paper ballots, excluding provisional, unreadable and/or damaged ballots.

Ballots and votes cast were manually tallied for the listed precincts and compared to the systemgenerated precinct reports.

<sup>&</sup>lt;sup>1</sup>Manual tally matched system report for total ballots but found 2 more votes than system report. Manual tally found in the mail ballots one more vote than system report. Technical services re-ran the mail ballots and the report matched what the manual tally found. In the polls ballots the manual tally differed on one contest from the system report; two supervisors examined and saw a match from ambiguous marking. Differences resolved.

<sup>&</sup>lt;sup>2</sup> Manual tally found one less ballot and two less votes than system generated report. Technical services re-ran the mail ballots and the ballot count matched but total votes did not. Two supervisors re-checked two contests and found from ambiguous markings that one matched and in turn the vote count matched. The other contest did not, which did not affect vote count. Difference partially resolved.

<sup>&</sup>lt;sup>3</sup> Manual tally matched total ballots and votes cast but were off on contests matching. Technical services re-ran the mail ballots and ballot and vote count continued to match. One contest did not but supervisors were then able to see a match from ambiguous markings. Difference resolved.

<sup>5</sup> Manual tally found two more ballots and 24 more votes than system generated report. Technical services re-ran the polls ballots and the system report matched the manual tally for ballots cast. Manual tally nearly matched votes from system report but was still off by one in 8 contests. When supervisors checked they found a match from ambiguous markings. Difference resolved.

<sup>6</sup> Manual tally found one less vote than system report and one contest that didn't match system report. Technical services re-ran ballots and ballot totals, vote totals and contests in system report matched manual tally. Difference resolved.
